ORDER:

In the reference 3rd read above, the Chief Executive Officer, Society for Elimination of Rural Poverty, A.P., Hyderabad has stated that on receipt of several representations from pensioners, District Level Pension Committees it is found that certain genuine pensioners were deleted from the list due to their absence before the Committees etc. and requested to restore the pensions to the eligible persons in their districts. Hence, he has requested the District Collectors to re-verify these roll back proposals, news applications etc. and confirm eligibility basing on most deserving cases to less deserving cases and as per numbers given to the District. After obtaining the list from the District Collectors, the Chief Executive Officer, SERP has requested the Government for consideration and sanction of 1,50,000 new pensions payable from May 2015 to be paid from 1st June 2015 as detailed below:
