ORDER:

In the G.Os.1<sup>st</sup> and 2<sup>nd</sup> read above, Government were issued orders guidelines for distribution and disbursement of Pensions under various Schemes in the Urban and Rural areas of the State.

2. In the G.O.3<sup>rd</sup> read above, Govt. issued Instructions for further payment of pension to the cases found to be falling in "never existed", "permanent migration" or "dead" categories shall be suspended forthwith. Suitable final action for deletion or payment of arrears can be taken after Gram Sabhas take a final view in each of these cases.

3. The Chief Executive Officer, SERP in his letter 4<sup>th</sup> read above reported that as per the guidelines, migration of a pensioner from his place of residence for more than six months shall be treated as permanent migration and the names of such pensioners shall be deleted from the live list and will be treated as vacancy.

4. Further reported that no uniform procedure has been specified for payment of arrears to the temporary migrants i.e., pensioners migrating for less than six months and who do not turn up for receiving pension regularly. Also reported that different districts are following different methods on payment of arrears in case of temporary migrants and there is a need for a policy on payment of arrears to the temporary migrants. The Chief Executive Officer, SERP has concluded that on the field observations and experiences certain guidelines are proposed for payment of pension arrears in respect of temporary migrants under Social Security Pensions scheme.

5. Government, after careful examination of the proposal of Chief Executive Officer, SERP, Hyderabad have decided to adopt the guidelines proposed for payment of pension arrears in respect of temporary migrants under Social Security Pensions Scheme:

- a) If the pensioner did not turn up on the first month for receiving pension and turns up on the second month, an amount of Rs.400/- will be paid i.e., 2<sup>nd</sup> month's pension of Rs.200/- + arrear of previous month's pension of Rs.200/-.

- b) If the pensioner turns up on the third month, an amount of Rs.600/- will be paid which includes current month's + two months arrears.
- c) After the end of three months, he/she will be treated as permanent migrant and his name will be deleted from the live pensioners list.
- d) The same principle will be applicable to disabled pensioners also.
6. The Chief Executive Officer, SERP, Hyderabad shall take necessary further action in the matter.
