ORDER:

In the G.O.10th read above, Government have issued orders for 100% reverification of all the proposed beneficiaries of mousing programme and Social Security Pensions under INDIRAMMA Phase-II.

- 2. Government after careful examination, hereby issue the following guidelines for undertaking 100% re-verification of the eligibility of the persons proposed for pensions under INDIRAMMA Phase-II by the specially constituted re-verification teams:
 - I. <u>Documents to be collected from the Mandal Parishad Development Officer before undertaking field verification in the field:</u>
 - Applications received from the beneficiary under Social Security Pensions.
 - II) Check List duly filled by the Panchayat Secretary with the recommendations of INDIRAMMA Monitoring Committee and Gram Sabha.
 - III) Gram Panchayat 2006 Electoral Roll.

II. Desk review:

The e-verification teams shall verify the list of beneficiaries proposed for Old Age Pensions and Gram Panchayat Voters' list to identify the beneficiaries whose age is less than 65 years.

III. Field verification:

The re-verification teams shall visit physically all the beneficiaries recommended by the Gram Sabha and reconfirm their eligibility strictly in accordance with eligibility criteria referred to at Para No.1 and also as explained below:

IV. Recommendations of the re-verification teams:

At the end of the field visit, the re-verification teams shall prepare the list of beneficiaries who are found ineligible in <u>Proforma A.1 to A.4</u> annexed to this G.O. The list of left out eligible persons shall be prepared in <u>Proforma B1 to B4</u> annexed to this G.O.

V. Final approval of the list:

At the Mandal, based on the reports received from the re-verification teams from the Supervisory Officers, the Mandal Parishad Development Officers will make necessary additions and deletions and submit final list to the District Collector through the Chief Executive Officer, Zilla Parishad.
