only one old age pension in a family even if other  
member of the family is eligible as per the criteria -

In order to facilitate the benefit of Old Age Pension to maximum number of families, it was decided to restrict the sanction of Old Age Pension to only one member of the family duly allowing sanction of pension for the combination of "Old Age Pension plus Widow Pension; Old Age Pension plus Disabled Pension; Widow Pension plus Disabled Pension and Old Age Pension plus Widow Pension plus Disabled Pension" to different members of the same family.

2. However, keeping in view the Order of the Hon'ble Institute of A.P. Lokayukta, Dated:27<sup>th</sup> June 2011 in Lr.Dis. No.1111/2010/B1/Lok/799/2011, Dt:9.4.2011 of Dy. Registrar, A.P.Lokayukta, Hyderabad (Complaint No./20/B1) filed by Sri N.Rasool of Kurnool District and after examination of the proposal submitted by the Chief Executive Officer, Society for Elimination of Rural Poverty, A.P., Hyderabad in the reference 2<sup>nd</sup> cited, Government hereby agree to provide the Old Age Pension to all the eligible individuals without reference to the same family, subject to falling within the overall pensions (numbers) sanctioned.

3. The Chief Executive Officer, Society for Elimination of Rural Poverty, A.P., Hyderabad is requested to take necessary action accordingly.
